a	criminal history consent form (page 14) must be completed and submitted with this application for each of the following: owner, sole proprietor, partner and managing agent (make additional copies as needed).
ti ti	Persons that are not U.S. Citizens must provide original Immigration Card I-551 to the Licensing Office for verification and copying.
